L'activité principale de l'entreprise est la production de ketchup, de sauces, de pâte de tomate sous ses propres marques et STM pour les chaînes de distribution fédérales et régionales.

Installations de production : Hangar n° 1 - 1 500 m², locaux de production, entrepôts opérationnels de matières premières, conteneurs, produits finis, locaux administratifs et domestiques. Hangar n°2 - 1 500 m², entrepôt principal. Une liste complète du matériel est envoyée sur demande.

L'entreprise fabrique des produits alimentaires du groupe de l'épicerie dans divers emballages à l'aide de lignes modernes et performantes. Six lignes d'une capacité de 40 000 unités par jour. Il existe toute la documentation nécessaire au fonctionnement de la production alimentaire - cela est confirmé par un audit complet de Rospotrebnadzor et des audits de grands réseaux fédéraux.
