Club de football croate de première division nationale HNS

La Hrvatska nogometna liga (prononcé [xɔʁʁʁaʔtskaʔ nɔʔdomeʔtnaʔ lɔʔʁʁaʔ]) (anglais : ligue de football croate), également connue sous le nom de HNL ou pour des raisons de parrainage SuperSport HNL, est la meilleure compétition de la ligue de football professionnel croate, créée en 1992.

Auparavant, elle s'appelait Prva Hrvatska nogometna liga (première ligue croate de football), mais une réorganisation de la structure de la ligue de 2022 à 2023 a conduit à des changements de nom pour les trois niveaux supérieurs de la ligue.

Fond

La ligue a été formée en 1991, à la suite de la dissolution de la Première Ligue yougoslave, et est gérée par la Fédération croate de football. Depuis sa création, la ligue a subi de nombreux changements dans son système et le nombre de clubs participants. Au cours des trois premières saisons, deux points ont été attribués pour une victoire, à partir de la saison 1994-95, cela a été changé en trois points. Chaque saison commence fin juillet ou début août et se termine en mai, avec une interruption de deux mois entre décembre et février. Actuellement, dix équipes participent à la ligue.

En 2022, seuls quatre des 12 membres fondateurs de la ligue croate n'ont jamais été relégués : Dinamo Zagreb, Hajduk Split, Osijek et Rijeka.

Points clés

En compétition dans la première ligue en Croatie, cette équipe SANS DETTE a déjà participé à l'UEFA.

Fondé il y a 90 ans et situé dans une zone économique forte en Croatie. Le stade sera modernisé grâce à une subvention de la Fédération croate de football et du gouvernement croate (sans frais pour le club)

Le club a une académie avec 350 joueurs et le stade existant peut accueillir 3400 fans
